7.4 Somerset Record Society Report 2022

Dr Robert Dunning informed the members of the work of the Somerset Record Society over the past 2 years including the completion of Volume 99 in 2021 and a paperback guide to Bishop Registers in 2022.

Matthew Blows addressed the meeting on the progress of conversion to CIO. He explained that the Charity Commission proposes a constitution which, it is hoped, will form the basis of SANHS CIO constitution with slight amendments. Trustees would have limited liability although would still have legal obligations. It was hoped that our application would be submitted within the next few days. Assets and liabilities would be then listed, ready for transfer in December 2023.

It was explained that the two charities would run alongside for a while in 2024 to enable all monies (from subscriptions and donations) to be transferred across. CIO trustees would be appointed by the existing trustees until they could be elected at the 2024 AGM.

A number of questions were asked by members on the practicalities of the conversion. Chris Jessop thanked the Board for all their work in getting this process started. Lizzie Induni thanked Matthew Blows for all his efforts in this conversion and his support to the Board.

8. Proposals

8.1 To approve the arrangements for the dissolution of SANHS and the transfer of its assets and liabilities to SANHS CIO.

The proposal was unanimously adopted by the members.

8.2 To approve an amendment to the present Society's Constitution to allow the removal of Holding Trustees.

The proposal was unanimously adopted by the members.
