FAMILY AND ESTATE

STRACHEY OF SUTTON COURT (*additional*): Kirkpatrick family: official papers and writings of William and James Kirkpatrick, successively residents at Hyderabad, including (*inter alia*) virtually all the items listed in the Historical Manuscripts Commission's *Appendix to the Sixth Report*, pp. 404-407, 1782-1811. Wilkieson family of Woodbury, Cambridgeshire, and elsewhere (related by marriage to Strachey): wills, executorship and family papers, correspondence, etc., 1754-1868. Strachey: deeds and abstracts of title, relating to the Sutton Court estate in Chew Magna, Buckland Dinham, Elm, Weare, etc., 1568-1837; surveys and particulars of Sutton Court and various properties in Stowey, 1641-1858; maps and surveys of Buckland Dinham, 1803, and Elm, 1804; wills and inventories of Strachey and related families, 1630-1793; accounts, etc., relating to work done at Sutton Court, 1852-1862; journals of a tour in France, 1768, and of a voyage to New Zealand, 1851-1852; correspondence and household accounts of Sir Henry Strachey, 1826-1858, and Sir Edward Strachey, 1842-1886; personal and literary correspondence and papers of Sir Edward, 1838-1901, including his MS. autobiography. Frances, Countess Waldegrave: domestic, etc., accounts for herself and her third and fourth husbands, including various relating to Strawberry Hill, 1848-1887; personal correspondence received 1851-1885; correspondence, etc., relating to Radstock affairs, management and produce of collieries, associated road and railway matters and the day and Sunday schools, 1848-1861.

SANFORD OF NYNEHEAD (*additional*): correspondence of Edward Clarke, 1673-1704, and his MS. and printed papers as M.P., 1693-1709; Nynhead estate rentals, 1821-1871; correspondence, bills and vouchers, largely during the life-time of Edward A. Sanford, c. 1830-1870, limited numbers of papers involving him as M.P., 1825-1837, and notebooks, probably as Chairman of Quarter Sessions, 1839.

LYTE OF LYLES CARY: the commonplace book of Thomas Lyte containing abstracts of numerous documents relating to the family and their estates in Charlton Mackrell, Charlton Adam, etc., largely 16th and early 17th centuries, but reciting from the 13th century, compiled c. 1620, and two decorated pedigrees of the Lyte family compiled by the same Thomas Lyte, one being dated 1633 (See H. C. Maxwell Lyte *The Lyles of Lytescary* for all three items).

II. SUMMARIES OF CATALOGUES OF MS. HOLDINGS

These summaries are intended to give more detail of MS. holdings for which catalogues exist in the Somerset Record Office.

DICKINSON OF KINGWESTON MSS.

Briefly, this deposit consists of a typical estate accumulation built up during the century after the family's acquisition of its seat at Kingweston in the middle of the 18th century, augmented by an extensive series of business and personal correspondence covering five generations of the family, records of the family's Jamaican plantations, business records of Graffin Prankard, a Bristol merchant, and the personal and official records of the (related) Fuller family of Sussex, which also had Jamaican interests.

Correspondence: business, estate and personal correspondence of Caleb Dickinson, initially a Bristol merchant, having also estates in Jamaica and (from c.1744) an interest in the Flat Holm Lighthouse, 1736-1778; correspondence of William, son of Caleb Dickinson, 1763-1806, including letters from Rye, Sussex, which he represented in Parliament 1777-1790; letters and papers of William's son William, 1795-1836, including some bearing on sessions and parliamentary business; letters of Francis H. Dickinson, reflecting his wide ranging activities as an M.P., J.P., and a man with interests at national and local level in the church, education and church architecture, 1833-1857; personal correspondence of a third William Dickinson, 1874-1907.

Business records: letter books and accounts of Graffin Prankard (father-in-law of Caleb Dickinson), a Bristol merchant trading with Northern Europe and America, 1712-1755; accounts of William Alloway, merchant of Minehead and Bridgwater trading with S. Ireland, 1683-1704; management of the Dickinson family's Jamaican plantations, 1716-1849; business and estate accounts, 1737-1805.

Fuller family of Rose Hill, Sussex: personal and business correspondence and papers, 1745-1767; official papers of Stephen Fuller accumulated as agent for Jamaica, c.1752-1799.
