## FAMILY AND ESTATE:

SLADE OF MONTYS COURT: deeds, etc., of Norton Fitzwarren and Hillfarrance, 1631-1869; survey and map of North Petherton, 1770, and of Wey Farm in Norton Fitzwarren, 1821; Slade family settlements, wills, commissions and correspondence, 1755-1867.

HANCOCK OF WIVELISCOMBE This collection, which represents only a fraction of the holding of Hancock MSS in the Record Office, contains a large element of the direct records of a solicitor's practice, a few records of other businesses, accumulated in cases of bankruptcy, family and business records, including some of earlier generations of the Hancock family, and Huish Champflower parish, etc., records. The professional records span the working life of Philip Hancock of Ford in Wiveliscombe, initially articled to Abraham Stevens of Nether Stowey, then in partnership with him for a limited period, but largely apparently in practice alone. There are also a few records of Stevens's earlier activities and later records of Philip's son, another Philip, but the bulk fall between c. 1795 and c. 1835.

THE SOMERSETSHIRE ARCHAEOLOGICAL AND NATURAL HISTORY SOCIETY'S MSS.

For many years from its foundation the Society received gifts or deposits of private estate and family archives, during a period when the Record Office's holdings were still of official archives and its strong rooms had not been opened to receive unofficial records. A vast holding of varied manuscripts was thus accumulated, representing within its limitations a record office in miniature. From 1935, however, by which time the scope of the Record Office had been extended and the first professional archivist appointed, transfers have been made at irregular intervals of the Society's holdings until now virtually all have been deposited. Summary lists of individual accessions were prepared as they were transferred or existing lists taken over, and within the last twelve months the entire collection has been checked and the lists revised, accession by accession: there remain the formidable tasks of indexing and typing. In the meantime, the records can be made more accessible through the medium of these reports. The present report covers all accessions from 1935 to 1949, when the transfers were mainly of deeds and associated records. The later accessions, which were much more varied in content, will be reported in the next volume.
