II. SUMMARIES OF CATALOGUES OF MS. HOLDINGS

These summaries are intended to give more detail of MS. holdings for which catalogues exist in the Somerset Record Office.

PHELIPS OF MONTACUTE MSS.

This collection consists of two elements: a traditional accumulation of estate and family records, dating from the early 17th century, and a series of papers, bound (often haphazardly) into volumes about 100 years ago, relating partly to national and public local, and partly to the family's domestic and personal, affairs. The records of wider significance belong largely to the career of Sir Robert Phelips, M.P. (d.1638), and many of those relating to national events and persons were listed in the *Appendix* to the *Third Report of the Historical Manuscripts Commission* (1872), pp. 281-287. The remaining papers in the bound volumes, not listed in the 1872 *Report*, have been calendared (i.e. the individual documents have been separately numbered and described) in the office's summary catalogue of the collection.

In the face of such a collection, it is perhaps churlish to regret that which does not survive, but it is disappointing that both elements of the collection begin one generation too late. Thus, there is little for the political career of Sir Robert's father, Sir Edward Phelips, sometime Speaker and Master of the Rolls, among the public papers, and nothing at all to throw any light upon the building of Montacute House, traditionally assigned to the same Sir Edward, or the establishment of the family's position there among the estate papers.

As a tail piece to the office catalogue and to this present report, details have been noted of the distinct group of more recent estate management records deposited independently through the family's solicitor.

GIBBS MSS.

This collection falls naturally into two sections: a limited number of late records relating to the Barrow Court estate purchased by Antony Gibbs in 1881; and a larger holding of records of the Gore family, owners of the estate to 1855. The latter were not inherited by the Gibbs family upon their purchase, but are believed to have been disposed of in or soon after 1855 and were subsequently presented to H. M. Gibbs, a later owner of the estate. The documents were catalogued by the Bristol historian, John Latimer (1824-1904) and many of the smaller documents were guarded and bound in nine volumes, arranged chronologically under four general subject headings.
