II. SUMMARIES OF CATALOGUES OF MS. HOLDINGS

These summaries are intended to give more detail of MS. holdings for which catalogues exist in the Somerset Record Office.

GORE LANGTON MSS.

This collection contains the purely estate records of the Gore and Langton families, which were united by the marriage in 1783 of William Gore and Bridget, only child of Joseph Langton of Newton Park, received through the family solicitors. Consequently, although there are interesting records relating to the acquisition of property and the management of estates and manors, both before and after the above union, there are, unfortunately, no personal papers, correspondence, etc., nor any records relating to the building of Newton Park.
