

NOTES ON

An Eighteenth Century Armory of Somerset

THE Somerset Archæological Society possesses an armory of the county compiled by James Harris, a herald-painter of Bath, the reputed date of which is 1770. The official Visitations of the heralds ceased in 1686, and county armories were made rarely after that date. Harris did not record arms which had merely an historical interest, but attempted, and not without success, to produce a current though unofficial heraldic Visitation of Somerset. The status of the persons mentioned in the third and fourth sections of his MS. corresponds closely to the status of those who were summoned by the heralds during the two previous centuries to register their arms. Few, however, of the Visitation families of the Tudor and Stuart periods occur in this Georgian list.

Though it does not appear that Harris published his collection of Somerset arms, probably he intended to do so.

The MS. was given to the Somerset Archæological Society in 1924 by Mr. St. David Kemys-Tynte. It measures 12 x 9 in., and is bound in contemporary marbled boards with a calf back, bearing a label on which is stamped the word, 'Somerset'. Possibly the volume was one of a series of county armories. In a corner of the cover there is a short inscription; 'C. K. K. Tynte, Esquire, Halswell'. Colonel Charles Kemys Kemys-Tynte, who was born in 1778 and died in 1860, would therefore seem to have owned the book, but there is no indication whether he purchased it or whether he obtained it by inheritance. He was grandfather of the donor.

There is a descriptive title on the fly leaf—

The / Paternal Coats of Arms and Crests / of the Nobility,
Baronets, and Gentry / Resident in or who have Seats in /
The County of Somerset / collected from Authentic Manu-
scripts and other Authorities / by / James Harris / Herald
Painter at Bath / 1770

The whole MS. would seem to have been compiled at one time, but it may be doubted from internal evidence whether the date of compilation was quite as early as 1770 : for instance, Sir Onesiphorus Paul was not created a baronet until 1774, though his name occurs in the list of baronets.

Following the title, there is an index or list of names¹ on plain paper, preceding fourteen sheets, each of which has twelve shields engraved on it with a ribbon below each shield. The first of the fourteen sheets has the arms of peers connected with the county engraved in the shields, with their names and titles on the ribbons. These arms have been coloured by hand. The arms of baronets, knights and esquires have been drawn and coloured in the blank shields on the following nine pages. In almost all cases the arms are surmounted by crests. The remaining four pages of blank shields were not used.

Unfortunately one sheet of arms is missing, but the identity of the twelve persons whose arms were on this sheet can be ascertained from the written description on the back of the following sheet, for in each case particulars of christian name, title and chief seat were given on the page opposite the arms. In the same way, it is possible to obtain from the index the information from the back of the missing sheet.

The writer has not included the arms of the peers and baronets in these notes as they can be ascertained so easily elsewhere. Those of the knights and esquires are fully described as many of them are little known, and as Harris had, no doubt, opportunities of recording them accurately, or at any rate in the form in which they were commonly used.

It is evident that Harris was not interested in the correct spelling of names of persons and places. His inconsistencies were so frequent that he cannot be said to have provided any

record of usual contemporary forms, and, consequently, no attempt has been made to transcribe names as he spelt them.

The list of names preserved by Harris, apart from the interest of his heraldic researches, has its value as a foot-note to the social history of Somerset.

Crest—*A dexter arm embowed in armour proper, gar-nished or, the hand apaumée also proper.*

BENJAMIN ALLEN Esq. Chief Seat at Bridgwater.

Sable, a cross potent or.

Crest—*A demi-lion rampant azure holding a rudder or.*

RALPH WARBURTON ALLEN Esq. (a minor). Chief Seat at Prior Park near Bath.

Quarterly 1 and 4, *Per bend rompu argent and sable, six martlets counterchanged, ALLEN*; 2 and 3, *Argent, a chevron between three cormorants sable, WARBURTON.*

Crest—*A blackbird rising sable, beaked and legged gules.*

PHILIP ALLEN Esq. Chief Seat at Bathampton near Bath.

Arms : ALLEN as above. Crest : as above.

The Revd. (? LANCELOT) ST. AUBIN. (The christian name is not given.) Chief Seat at Alfoxton.

Ermine, on a bend gules three bezants.

Crest—*A squirrel ermine, collared, lined and ringed or.*

COPPLESTONE WARRE BAMPFYLDE Esq. Chief Seat at Hestertcombe near Taunton.

Quarterly 1 and 4, *Or, on a bend gules three mullets argent BAMPFYLDE*; 2 and 3, *Gules, crusily fitchée or, a lion rampant argent, WARRE.*

Crest—*A lion's head erased sable, langued and ducally crowned gules.*

EDWARD BERKELEY Esq. Chief Seat at Pylle.

Gules, a chevron ermine between ten crosses pattée, six and four.

Crest—*A unicorn passant gules.*

'Supported by Naked Men' is written below the drawing of the arms.

PHILIP BENNET Esq. Chief Seat at Widcombe near Bath.

Gules, a bezant between three demi-lions rampant argent.

Crest—*Out of a mural coronet or, a lion's head gules charged on the neck with a bezant.*

ROBERT BALSH Esq. Chief Seat at St. Audries near Bridgwater.

Barry of six or and azure, on a bend engrailed gules three spear heads argent.

Crest—*A demi-griffin segreant vert.*

ZACHARY BAYLEY Esq. Chief Seat at Bowlish near Shepton Mallet.

Ermine, on a fess engrailed between three horses' heads erased azure as many fleur-de-lis or.

Crest—*Out of a ducal coronet or, a horse's head azure.*

JAMES BARNARD Esq. Chief Seat at Crowcombe (late the Carews').

Argent, a bear salient sable.

Crest—*A demi-bear salient sable.*

The Revd. HUMPHREY BRENT. Chief Seat at Hutton near Axbridge.

Gules, a wyvern with wings displayed argent.

Crest—*A wyvern's head between its wings argent, charged on the breast with three ermine spots, two and one.*

MATTHEW BRICKDALE Esq. (Member for the City of Bristol.) Chief Seat at Knowle near Bristol.

Azure, a chevron or between three sheaves of five arrows of the second, flighted and pheoned argent, banded gules.

Crest—*Out of a ducal coronet or a demi-lion rampant supporting a spear proper, thereon a standard azure fringed gold, charged with a sheaf of five arrows as in the arms.*

JOHN BURLAND Esq. (One of His Majesty's Sergeants at Law.) Chief Seat at Steyning in the parish of Stogursey.

Quarterly 1 and 4, *Ermine, on a chief embattled gules three roses argent seeded of the last (or three cinquefoils argent pierced of the last), BURLAND*; 2 and 3, *Argent, a fess between three lions couchant guardant gules.*

Crest—*A griffin's head erased argent, on the neck a fess gules charged with three roses (or cinquefoils) as in the arms.*

CAREW of Camerton. Extinct (*vide* Barnard).

Or, three lions passant sable.

Crest—*A mainmast or, and out of the round top a demi-lion rampant issuing sable between six spears, three and three, argent.*

'Supported by a stag and a lion' is written below the arms.

EDWARD CLARKE Esq. Chief Seat at Chipley near Wellington.

Argent, three bars azure in chief as many escallops gules.

Crest—*A dexter arm in armour embowed holding in the gauntlet an arrow all proper.*

HENRY CHICHESTER Esq. Chief Seat at Northover near Ilchester.

Chequy or and gules, a chief vair.

Crest—*A heron rising, an eel in the beak, all proper.*

JOHN COLLINS Esq. Chief Seat at Hatch Beauchamp.

Quarterly 1 and 4, Gules, on a bend or three martlets sable; 2 and 3, Gules, a crescent between eight martlets argent.

Crest—*A demi-griffin segreant or.*

RICHARD COMBE Esq. Chief Seat at Earnshill near Ilminster.

Argent, three lions passant guardant gules.

Crest—*A dexter arm embowed in armour holding in the gauntlet a falcheon all proper.*

THOMAS COWARD Esq. Chief Seat at Spargrove.

Argent, on a chevron gules three martlets or, on a chief of the second a demi-culverin dismounted of the third.

Crest—*A demi-hound holding a roe-buck's head cabossed argent attired or.* (cf. *Proc. S.A.S.*, lxxxiv, ii, 80, LEIGH of Wells.)

RICHARD HIPDISLEY COXE Esq. (Representative in Parliament for the County of Somerset.) Chief Seat at Ston Easton near Wells.

Sable, a chevron between three bucks' scalps argent. (cf. Arms given in Somerset M.P's, Supplement, *Proc. S.A.S.*, lxxxv.)

Crest—*A hind's head erased or, on the neck a fess sable charged with three mullets of the first.*

RICHARD CROSS Esq. Chief Seat at Broomfield near Taunton.

Quarterly argent and gules, in the first quarter a cross crosslet of the second.

Crest—*A cross pattée fitchée argent between a pair of wings displayed gules.*

HILL DAWE Esq. Chief Seat at Ditcheat near Castle Cary.
Argent, on a pile gules a chevron between three crosses crosslet or.

Crest—*A lion's gamb erased sable holding a fleur-de-lis or.*

DAVIS of Wells.

Or, a griffin segreant sable.

Crest—*A griffin as in the arms.*

Cf. **MORGAN** of George's below.

CALEB DICKINSON of Kingweston. (L.)

SAMUEL DODINGTON Esq. Chief Seat at Horsington.

Sable, three hunting horns stringed argent.

Crest—*A buck lodged argent, holding in the mouth a sprig of leaves vert.*

JOHN DONNE Esq. Chief Seat at Westcombe.

Azure, a wolf salient argent, a chief of the last.

Crest—*Six serpents party per pale vert and argent, three in bend and three in bend sinister, bound by a torse of the second and gules.*

JOHN DURBIN Esq. Chief Seat at Walton-in-Gordano.

Or, on a bend gules three mullets argent.

Crest—*A mullet gules.*

THOMAS DYKE Esq. Chief Seat at Waterhouse near Bath.

Or, three cinquefoils sable pierced of the field.

Crest—*A dexter cubit arm habited sable, in the gauntlet or a cinquefoil slipped of the last.*

GOODENOUGH EARLE Esq. Chief Seat at Barton near Taunton.

Gules, three escallops argent, a bordure engrailed of the last.

Crest—*A lion's head erased or pierced through the neck by a spear bendwise argent.*

HARRY EDGELL Esq. Chief Seat at Standerwick.

Argent, on a chevron embattled sable between three cinque-foils gules as many mullets of the field.

ISAAC ELTON of Winsford. (L.)

JOHN FRAUNCEIS Esq. Chief Seat at Combe Florey.

Argent, three mullets gules pierced of the field.

Crest—A pine tree proper fructed gold.

HENRY GAPPER Esq. Chief Seat at Wincanton.

Or, a saltire gules, on a chief of the last three lions rampant of the field.

JOHN GORE Esq. Chief Seat at Barrow near Bristol.

Gules, a fess between three crosses crosslet fitchée or.

Crest—On a mount vert, an heraldic tiger salient argent collared or.

HENRY GROSVENOR Esq. Chief Seat at Swell near Langport.

Azure, a garb or.

Crest—A talbot passant or.

HENRY HARRINGTON M.D. of Bath.

Sable, a fret humettée argent.

Crest—A lion's head erased gules.

CAESAR HAWKINS Esq. Chief Seat at Kelston near Bath.

Argent, on a saltire sable five fleur-de-lis.

Crest—On a mount vert a hind lodged gold.

HENRY CORNISH HENLEY Esq. Chief Seat at Leigh near Chard.

Azure, a lion rampant argent ducally crowned or, within a bordure of the second charged with eight torteaux.

Crest—A lion's head erased argent ducally crowned or.

JOHN HALLIDAY Esq. Chief Seat at Taunton.

Sable, three closed helmets argent within a bordure engrailed of the last.

Crest—A demi-lion rampant guardant or.

SWAIN HARBIN Esq. Chief Seat at Newton near Yeovil.

Azure, a saltire voided between four spear heads erect or.

(The saltire and spear heads have been left untinctured.)

Crest—A dexter cubit arm in armour or holding in the gauntlet argent a spur of the first. (The representation of the crest does not correspond exactly to the patent.)

Azure, a cross vairé or and of the first between four mullets of the second pierced of the field.

Crest—*On the stump of a tree lying fess-ways a hawk proper.*

Sable, three talbots passant argent.

Crest—*A talbot segeant argent collared and lined or.*

WILLIAM HELYAR Esq. Chief Seat at East Coker near Yeovil.

Azure, a cross florey argent between four mullets or.

Crest—*A cock sable under a cross crosslet fitchée or.*

THOMAS HUNT Esq. Chief Seat at Compton Pauncefoot near Wincanton.

Azure, a chevron between three martlets argent.

DODINGTON HUNT of Pitcombe. (L.)

Barry of six ermine and gules.

Crest—*A boot sable spurred or surmounted by a heart supported by two hands proper.* (A ribbon, on which is the motto *Cor Immobile*, is drawn above the crest and connects the two hands.)

Argent, a lion rampant azure between three escallops gules.

Crest—*A demi-lion rampant azure holding an escallop as in the arms.*

Sable, a lion rampant or between five crosses crosslet fitchée argent.

Crest—*Out of a ducal coronet a demi-lion rampant or.*

NORTON KNATCHBULL Esq. Chief Seat at Babington near Frome.

Azure, three crosses crosslet fitchée between two bendlets or.

(The bendlets have been represented in error between the crosses crosslet.)

Crest—*On a chapeau azure turned up ermine a leopard argent pellety.*

JOSEPH LANGTON Esq. Chief Seat at Newton Park near Bath.

Quarterly sable and or, a bend argent.

Crest—*A eagle or and a wyvern vert their necks intertwined reguardant.*

RICHARD LANDSDOWN Esq. Chief Seat at Woodborough near Bath.

Argent, an eagle displayed gules.

Crest—*A demi-eagle displayed gules.*

JOHN LOCKYER Esq. Chief Seat at Ilchester.

Argent, on a bend sable three single shackle-bolts.

JOHN LETHBRIDGE Esq. Chief Seat at Hill (Sandhill) near Taunton.

Argent, over water proper a bridge of five arches turreted gules, in chief an eagle displayed sable.

Crest—*A demi-eagle displayed sable.*

HENRY FOWNES LUTTRELL Esq. Chief Seat at Dunster Castle.

Or, a bend between six martlets sable.

Crest—*Out of a ducal coronet or a plume of five feathers argent.*

EDMUND LOVEL, LL.D., of Wells.

Quarterly, 1, Barry nebulée of six or and gules ; 2, Argent, a chevron gules between in chief two ermine spots and in base an ermine spot reversed ; 3, Ermine a chevron sable ; 4, Ermine, on a chief indented gules three (? swans) argent.

Crest—*A wolf statant azure bezantée ducally collared or.*

GERARD MARTIN Esq. Chief Seat at Bruton.

Argent two bars gules.

Crest—*On the stump of a tree vert an ape proper, collared and lined or, admiring himself in a mirror of the second.*

The Revd. ALEXANDER MALET. Chief Seat at Combe Florey.

Azure, three escallops or.

Crest—*Out of a ducal coronet or a griffin's head sable langued gules.*

JAMES MARWOOD Esq. Chief Seat at Chaffcombe.

Gules, a chevron ermine between three goats' heads erased or.

Crest—*A ram couchant argent.*

THOMAS HUTCHINGS MEDLYCOT Esq. Chief Seat at Venn.

Quarterly per fess indented azure and gules, three lions rampant argent.

JAMES MELLIAR Esq. Chief Seat at Galhampton.

Argent, three martlets gules, on a chief engrailed of the last two annulets or, a canton ermine.

Crest—*A lion's gamb erased sable holding a branch of myrtle proper.*

CAREW HARVEY MILD MAY Esq. Chief Seat at Hazle-grove.

Argent, three lions rampant sable.

Crest—*A lion rampant azure.*

WILKINS MORGAN Esq. Chief Seat at St. George's near Bristol.

Or, a griffin segreant sable.

Crest—*A griffin as in the arms.*

Cf. DAVIS of Wells above.

— MORRIS of Hassage (Wellow). (L.)

JOHN MORDAUNT Esq. Chief Seat at Berkeley near Frome.

Argent, a chevron between three estoiles sable pierced of the field.

Crest—*Out of an earl's coronet or a blackamoor's head wreathed about the temples with a torse twisted argent and gules.*

JOHN MOSS of the City of Wells.

Quarterly 1 and 4, Ermine, a cross pattée sable pierced of the field ; 2, Argent, three mullets gules, a bordure en-

grailed of the last ; 3, Argent, three leopards' faces jessant-de-lis gules.

Crest—Out of a mural coronet or a griffin's head ermine charged on the neck with a cross pattée as in the arms.

Argent, on a fess sable between three cinquefoils vert a cross patonce or.

Crest—A dragon's head couped vert langued gules charged on the neck with a cross patonce as in the arms.

Vair, a bordure gules charged with eight crosses crosslet or.

Crest—A dexter cubit arm proper holding a cross crosslet or.

Quarterly sable and argent, in the first and fourth quarters three mullets of the second, in fess an inescutcheon gules charged with a portcullis imperially crowned or. (The inescutcheon was an honourable augmentation granted by Charles II to Colonel Newman for his distinguished conduct at the battle of Worcester.)

Argent, a chevron between three roses gules.

Crest—A square beacon on wheels or filled with flames proper.

'Supported by lions' is written below the arms.

Crest—A wolf's head erased argent langued gules.
